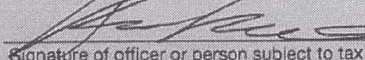

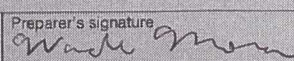

Since our founding in 2010, Revelation Wellness has trained approximately 4,000 instructors who now serve diverse populations, including inner cities, kids' ministries and camps, prisons and jails, shelters, survivors of trafficking, nursing homes and senior care, teens and high school ministries, individuals with special needs, international missions, addiction recovery groups, veterans and military families, immigrant and refugee communities, and churches across the nation and globe. We continued to steward our digital media platforms to proclaim the Gospel boldly and creatively. Through our podcast, YouTube channel, and website, we delivered hundreds of workouts and teaching messages, reaching thousands of people with the transformational love of Jesus. In 2024, we also launched RW+ - our new digital community that provides access to nearly all Revelation Wellness programs for a minimal monthly fee. In its inaugural year, RW+ welcomed 2,050 people into a supportive, Christ-centered space designed to help them live out our mission every day.
